Chairman Kelso asked about field entrance size requirements. If a culvert is replaced the general rule is to replace with 60 foot (two 30 ft.) and owner pays for one 30 foot section and the County pays for 30 foot and all installation costs. Discussion was held on the culvert replacement practice.
