October 18, 2017

The monthly meeting of the McDonough County Board was held at the McDonough County Courthouse at 7:00 p.m. roll call resulted in 19 present, 2 absent. Sheriff Rick Van Brooker made the opening declaration. Board Member Sims led the Pledge of Allegiance.

The report from Public Defender, Nigel Graham for the month of September 2017 was received and filed. Chairman Schwerer stated cases were up with 764 at the end of the month.
