Tri-County R & WM Report

Tim is still working with Mr. Schaab on a cost model for rural recycling.

Veteran's Assistance and Van Report

Veteran's Superintendent Ric Smart presented the monthly report. Eleven veterans were given assistance in June amounting to \$ 2,064.30. The transportation van made 17 trips to Iowa City transporting 36 Veterans.

Sheriff's Report

Sheriff Rick VanBrooker presented the monthly report. The average daily population was 45. They have done a media blitz on the car they are looking for in connection with the recent drive by house shooting in Bushnell. The balance in the Inmate Medical account is running close.

Chairman Hiel thanked the Sheriff and his staff for their professional and swift assistance in a personal issue recently.
