The Elms is still a "5Star Overall Quality" 4 Star Health Inspection, 4 Star Quality Measurers, 5 Star Staffing and 5 Star RN Staffing ratings. The Elms has 5 residents that still have not contracted COVID-19. IDPH has relaxed some of the COVID-19 processes for bio waste and use of paper products from the kitchen for person with COVD-19. The facility has spent an extra \$60,000 to \$70,000 in PPE, disposable kitchen supplies, COVID-19 testing supplies and Bio Waste disposal for the month of November.
