Engineer Rick Walker gave an update. They should be done with the piling on Center Church Road this week. After the beams are in it should go quick. Engineer Walker projects finishing up as soon as July or August.

Bushnell bridge project has been hit or miss with the weather. When the weather changes it should go quicky. Member Foster asked about the density. Engineer Walker stated it looks good and tight. He also stated that there will be a flat shoulder and it should be done by the end of June or July depending on the weather.

Engineer Walker also informed the Committee that County Highway 24 should start next week. They should Seal Coat by the end of July. He also stated that they have increased the price of the seal coating to .60 cents a gallon.

Engineer Walker informed the Committee that they have not received the truck yet, but should be getting it within the next month.

Engineer Walker also confirmed that they will receive \$134,322.00 of COVID money to be spent on Federal projects with a September 2024 deadline.
