CO2 Pipeline Discussion

Chairman Erlandson summarized the Navigator Heartland Greenway Pipeline project activity since the last meeting. He also reviewed the following actions that those opposed to the pipeline have requested the County Board to take:

1 - Create an emergency response plan

2 - Update the public utility permit crossing application to include CO2 pipelines

3 - Adopt zoning that regulates setbacks and addresses emergency response planning; repair of damaged field tiles, damage to farmland that results in yield loss, etc.

4 - Join other local units of government in intervening in the Illinois Commerce Commission's processing of Navigator's project

5 - Resolution

6 - Moratorium

After discussion by members of the Committee, the following items were decided:

1 - Recommend to the Full Board at the September 21st meeting that McDonough County file a petition to intervene in the Navigator case with the Illinois Commerce Commission

2 - Status of emergency planning will be pursued through the ESDA/Claims committee and McDonough County ESDA Director Edgar Rodriguez

3 - Zoning, ordinance, and moratorium options will be considered at a later date after additional legal opinions are received
