Brian Frericks with QCP to Discuss Gas Contract and Solar Power at the Elms

Brian Frericks informed the Committee that the current gas contract will expire on April 30, 2024. He discussed gas rates and said that the new contract will need to start on May 1, 2024, more detailed pricing report will be sent next week. Solar power at the Elms would cost \$662,064.00, the Federal Government, State of Illinois and Ameren have incentive funds available that could be up to \$567,115.00.

Member Cox made a motion for an Index and Basis for a 24-month period for gas rates moved with a second by Member Murphy. Motion carried on a voice vote.
